JUDGE TO THE SUPERVISING JUDGES**

**GENERAL ORDER OF THE  
PRESIDING DEPARTMENT**

**ORDER NO. 010125-05**

THIS COURT FINDS AND ORDERS AS FOLLOWS:

Pursuant to California Rules of Court, rule 10.603, and the authority set forth below, the following duties are delegated from the Presiding Judge to the Supervising Judges:<sup>1</sup>

- The authority to sign a formal judgment, pursuant to Code of Civil Procedure section 635, when a decision of the court has been entered in the minutes and the judge who heard or tried the case is unavailable. For purposes of this delegation, the term “unavailable” may include, but is not limited to, a judge that has been transferred to a new assignment, except as set forth in *People v. Rodriguez* (2016) 1 Cal.5th 676. However, this does not prohibit transmitting the judgment or order to the judge who heard or tried the case for review and signature, unless that judge is no longer a judge of this court.


- 1           • The authority to issue orders in response to challenges made pursuant to Code of  
2 Civil Procedure section 170.6, if the challenged judge is unavailable, except in  
3 Probate matters. For purposes of this delegation, the term “unavailable” may  
4 include, but is not limited to, a judge that has been transferred to a new assignment,  
5 except as set forth in *People v. Rodriguez, supra*, 1 Cal.5th 676.
- 6           • The authority to properly approve party stipulations to have cases heard by a  
7 temporary judge, in accordance with California Rules of Court, rule 2.831(a). After  
8 the parties have signed the Stipulation portion of the *Order, Stipulation and Oath*  
9 *for Temporary Judge* (San Diego Superior Court Form #CIV-349), the courtroom  
10 clerk may affix the approving judge’s signature to the form using the appropriate  
11 facsimile signature stamp.
- 12           • The authority to rule on a request to file new litigation by a vexatious litigant subject  
13 to a prefiling order, pursuant to Code of Civil Procedure section 391.7. This  
14 includes the authority to condition the filing of the litigation upon the furnishing of  
15 security for the benefit of defendants as provided in Code of Civil Procedure section  
16 391.3.
- 17           • The authority to rule on an application to vacate the prefiling order and remove the  
18 vexatious litigant’s name from the statewide list, when the judge who entered the  
19 prefiling order is not available, pursuant to Code of Civil Procedure section 391.8.

20           For purposes of this delegation order, the Assistant Supervising Judge may sign judgments  
21 or orders as delegated by the Supervising Judge.

22           This order shall become effective on January 1, 2025, and expire on December 31, 2025,  
23 unless otherwise ordered by this court.
